> ELECTIONS TO FILL A VACANCY ON THE FINANCE COMMITTEE IN ACCORDANCE WITH SECTION 9, PARAGRAPH 5, OF THE ANNEX TO THE AGREEMENT RELATING TO THE IMPLEMENTATION OF PART XI OF THE UNITED NATIONS CONVENTION ON THE LAW OF THE SEA

Note by the Secretary-General

1. The Assembly is invited to note that Sergei P. Ivanov (Russian Federation) has resigned from the Finance Committee with effect from 11 February 2000. Mr. Ivanov was elected as a member of the Finance Committee on 13 August 1996 for a term of five years with effect from 1 January 1997 (ISBA/A/L.13).

2. Section 9, paragraph 5, of the annex to the Agreement relating to the implementation of Part XI of the United Nations Convention on the Law of the Sea ("the Agreement") provides that in the event of the death, incapacity or resignation of a member of the Finance Committee prior to the expiration of the term of office, the Assembly shall elect for the remainder of the term a member from the same geographical region or group of States.

3. In accordance with Section 9 of the Agreement, the Finance Committee shall be composed of 15 members with appropriate qualifications relevant to financial matters. Members of the Finance Committee shall be elected by the Assembly.

4. By a note verbale dated 23 February 2000, the Embassy of the Russian Federation in Jamaica informed the Secretariat of the Authority of the nomination of Boris G. Idrisov, Deputy Director of the Financial Department of the Russian Ministry of Foreign Affairs, to fill the vacant seat on the Finance Committee.
